FMPC85/17 DECLARATION OF INTEREST

FMPC86/17 MINUTES OF PREVIOUS MEETING

The Minutes of the Parish Council meeting held on 12th September 2017, were approved and signed. Proposed by Cllr. Johnston, seconded by Cllr. Reay.

FMPC87/17 ACTION UPDATES

- a) Site visit to discuss condition of pavement through village -
- As at date of meeting no report had yet been received from Highways.
- b) Village Assets Cllr. Jones ongoing on sign, grit bin on Broom Hill has slight damage but no action required for this.
- c) Funding of 'The Link' Clerk Cllr. Johnston proposed that a £20.00 a year be spent on advert or something else to help towards funding this, seconded by Cllr. Reay, all agreed.
- d) 'Welcome to the village' Leaflet ongoing. Clerk is to meet with E Wortley to obtain more history.
- e) Transparency Funding issues relating to this concerning amount received have been clarified and Clerk to be reimbursed Broadband costs as per funding claim.
- f) Order retro-data collectors for VAS signs Cllr. Johnston reports this is ongoing and it was confirmed that a donation of £250.00 from Borough Cllr. Smith and £350.00 donation from County Cllr. Spicer were to be made.

FMPC88/17 FINANCIAL REPORT

RFO presented the Annual return and Auditors Certificate – signed by Cllr. Jones. The proposed Budget was then presented to the Council for consideration with amendments made and shown on attached copy. Cllr. Reay proposed acceptance of

FMPC89/17 CHAIRMAN'S REPORT

FMPC90/17 COUNTY COUNCILLOR'S REPORT

County Cllr. Spicer reported on the School Transport provision which is in jeopardy. At present the Council pay for both Ixworth Free School and Thurston Community College and subsidise transport for Thurston 6th Form College. A consultation to be held in December with regards to continuing this provision. Further report in January 2018. The Council will make savings of £27m next financial year having already made savings of £236m since 2011 (40% in 6 years).

FMPC91/17 BOROUGH COUNCILLORS REPORT

Borough Cllr. Andrew Smith reported that the WSOH had finally been granted permission subject to no calls from Secretary of State.

FMPC92/17 POLICE COMMUNITY SUPPORT OFFICERS REPORT

No report had been received, but the Clerk was able to report that nothing had been reported in Fakenham Magna since last meeting.

FMPC93/17 COUNCILLORS REPORTS

Cllr. Reay reported he had attended the last Barnham Village Hall committee meeting, they have a dispute with the school using the car park as they do not pay anything towards the upkeep.

Cllr. Rozier reported that concerns had been raised about what was proposed behind Old School Houses (currently up for sale), an area has been fenced off. Clerk to ask Euston Estate.

FMPC94/17 LOCAL HISTORY RECORDERS REPORT

Edward |Wortley reported that it will be 25 years in January 2018 that he became History Recorder for the village but that he didn't make his first meeting due to heavy snow falls.

Cllr. Johnston proposed a vote of thanks for all the work carried out over the last 25 years, seconded by Cllr. Jones.
